### MiChildSupport Case Information, Communication, and Calculator

MiChildSupport allows individuals to apply for child support, view an existing case, and make child support payments online. Those who have an established order may interact with Friend of the Court staff via two-way communication in MiChildSupport if the county where their case is located uses this feature.

It allows users to calculate a child support amount using the Michigan Child Support Formula; however, this amount is not a support recommendation or a support order. Before starting, users should have income information and the number of overnights with each child for both parents. Additionally, they will be asked to provide health care and childcare information for both parents and any custodian.

- **PayNearMe** – This service allows payers to make child support payments in cash at CVS, 7-Eleven, Family Dollar, Casey's General Store, and ACE Cash Express. First, payers must visit the PayNearMe website ([paynearme.com/Michigan](http://paynearme.com/Michigan)) to receive a payment code. Payers must have the following to receive a payment code:
  - Last four digits of their Social Security Number
  - Docket number (yyyy-xxxxxx)
  - First and last name
  - Email or phone number to receive the payment code, which the payer will provide to the location where the cash payment is madeNote: There is a \$1.99 processing fee.

## Child Support Arrears Management Programs

A payer who has child support arrearages may file a motion with the circuit court requesting to discharge or reduce arrearages when certain conditions apply. Payers may complete the *Motion Regarding Payment Plan/Discharge of Arrears* (FOC109) to request a payment plan. This applies to debt owed to the payee, to the state, or both.
